Safeguarding Children and Young People Statement of Commitment

Starlight Children's Foundation exists to brighten the lives of seriously ill and hospitalised children, young people and their families by providing positive and enriching experiences that support their well-being and resilience. Our most important responsibility is to ensure our programs are provided in an environment that is caring, nurturing and safe for all children and young people. To achieve this, we support, encourage and expect our team to strive for the highest possible standards with respect to safeguarding children and young people from abuse.

Starlight's Safeguarding Children and Young People policy is that as an organisation, we do all that we can ethically, morally and legally to safeguard the children and young people we work with from sexual, physical, emotional or psychological abuse. This is done by defining expected behaviours and processes to support a culture that prioritises the safeguarding of children, young people and families engaging in Starlight programs and fundraising activities.

By fundraising for Starlight, you are taken to have given the Starlight Children's Foundation an assurance that you have not been and do not intend to be:– Found guilty by a Court of a sexual offence against the person of a student or child; or– Dismissed from any employment on the grounds that you were/are involved in improper conduct of a sexual nature with a student or child; or– Retired or resigned from any employment following allegations that you were involved in improper conduct of asexual nature with a student or child; or– Advised by any employer that your name is included on a list of those not to be employed in a child-related area of activity.
